Preservation Utah advocates for preservation-oriented public policies by working with elected officials and administrators, supporting relevant legislation, and providing creative and sustainable solutions in collaboration with property owners. The Organization partners with the Utah State Historic Preservation Office to host an annual Preservation Conference and also provides education to the public through lecture series, ongoing tours, and cultural events. In all of its outreach, Preservation Utah aims to educate the public about Utah's architectural legacy and historic preservation. The annual Preservation Conference is the premier preservation conference in the State of Utah. A report is given to each property owner with suggestions on how to care for their property. The rehabilitation program provides the public with practical preservation training through guest lectures and workshops. The events focus on training in historic preservation techniques.

During the year ended December 31, 2023, management obtained additional information about the PAST loan fund which resulted in a change in its presentation on the statement of financial position. The PAST loan fund was originally established in 1981 through a loan from Salt Lake City of \$300,000. The creditor restricted the use of the funds for low-interest loans to qualifying property owners to be used for preservation and restoration of qualifying property. The fund was also allowed to be used by the Organization to purchase qualifying real property and sell it to a buyer who is willing to execute a preservation easement on the property. Through 2022, this agreement with Salt Lake City was presented on the statement of financial position as a note payable of \$300,000.

During the year ended December 31, 2023, management identified an agreement between the Organization and Salt Lake City dated September 2001 in which the original \$300,000 loan was converted to a perpetually donor-restricted contribution.
