A preservation easement is a legal agreement that gives the easement holder a responsibility to protect the visual and structural integrity of a particular historic structure, even though that structure is actually owned by another person. The intent of the preservation easement is to prevent anyone from demolishing or severely altering the historic building without the permission of the easement holder. The owner retains all the usual private property rights except for the right to destroy the property. Alterations, improvements, and even additions to the structure are allowed, as long as they do not compromise its historic character.

Preservation Utah's Preservation Easement Program is operated as a public

service. We hold easements and take on great responsibility with those easements. Each year, we send an easement inspector to evaluate each of our easement properties. The easement inspector examines each property and writes a report on the property's condition. These reports are kept in Preservation Utah's permanent records and are used as reference points when changes or alterations are proposed for an easement property, or when Preservation Utah needs to take preventative measures to secure a building's condition.

**Part II, Line 9 - Accounting for Conservation Easements**

The Organization has acquired its conservation easements through donation. The Organization considers its conservation easements to be collections, under GAAP, because they are held in furtherance of public service rather than for financial gain and they are protected, cared for, and preserved. The Organization does not sell its easements.

The Organization has elected not to capitalize its easements, under FASB ASC 958-360-25-3. Under FASB 958-605-19, contributed collection items that are not capitalized should not be recognized as revenues or gains.

The Organization has been recognized by the Internal Revenue Service (IRS) as exempt from federal income taxes under Section 501(c)(3), qualifying for the charitable contribution deduction under section 170(b)(1)(A)(vi), and has been determined not to be a private foundation under Section 509(a). Preservation Utah advocates for preservation-oriented public policies by working with elected officials and administrators, supporting relevant legislation, and providing creative and sustainable solutions in collaboration with property owners. The organization also provides education to the public through lecture series, ongoing tours, and cultural events. In all of its outreach, Preservation Utah aims to educate the public about Utah's architectural legacy and historic preservation. In 2021, Preservation Utah led 40 public tours, most of these free to the public. The tours included: Allen Park, Magna Main Street, Meditation Chapel, Memory Grove Park, Salt Lake City Cemetery, Modernism on South Temple, Salt Lake City Main Street, & Utah Governor's Mansion.

**Form 990, Part III, Line 4b - Second Accomplishment****Historic Properties**

Preservation Utah's historic properties program preserves and protects Utah's built environment through loan, easement, and restoration / rehabilitation projects. Since 1970, the organization has managed a revolving loan fund that offers low-interest loans to owners of historic property. Loan projects must meet national standards of historic preservation to be approved. Since the loan program's inception, entire neighborhoods have been revitalized. The easement program provides permanent protection for over 126 historic properties in the State of Utah.

Each year, Preservation Utah inspects these properties and rates their

conditions. A report is given to each property owner with suggestions on how to care for their property. The rehabilitation program provides the public with practical preservation training through guest lectures and workshops. The events focus on training in historic preservation techniques.

In 2021, Preservation Utah acquired no new easement properties. We did establish three loans totalling \$110,000. We inspected all of our 126 easement properties in 2021 and rated with reports of their condition and recommendations sent to the property owners. Additionally, we received a grant to implement an Arches database for the program which will help tremendously with managing the program.

Other Program

In 2021, Preservation Utah sponsored other programming that aligns with our mission, including the Preservation Conference, Heritage Awards, and Historic Home Tours. The annual Preservation Conference is the premier preservation conference in the State of Utah. It brings together preservation professionals, technical experts, students, property owners, and the general public to network and learn about preservation in our state. The organization's Heritage Awards annually recognize the best in Utah's preservation work. Award categories include rehabilitation & restoration, heritage organization or business, adaptive reuse, individual, and lifetime achievement. The organization's semi-annual home tours focus on varied historic neighborhoods in Utah. They are offered to the general public and provide education and history about the homes, neighborhoods, and architectural styles of the featured properties. Properties selected in

the tours demonstrate positive cases of historic preservation and are examples to be replicated by the public in their own rehabilitation work.

The Organization requires that board members with conflict of interest be recused from the deliberation and voting related to a transaction or action in which they may have conflict.
